Registration Contract

This constitutes the agreement between student / responsible party and Dance Source Performing Arts Studio, for all classes and / or activities the student is pursuing at or with Dance Source Performing Arts Studio. Please Note: “You or Student” below represents either the student or responsible party.

1. Tuition/Billing: Monthly Tuition is due on the 1st of each month. Tuition paid by the 10th will receive a \$10.00 discount. NO REFUNDS will be given for classes not attended. You agree that your monthly tuition will stay the same whether there are 2, 3, 4, or 5 weeks in the month. PLEASE NOTE: By signing below you agree to pay your monthly tuition through May 2022. You are responsible to pay for each month regardless of attendance.

2. DELINQUENT TUITION/FEES: Tuition that is paid by the 10th of each month will receive a \$10 discount. Tuition that is not paid by the 10th of each month will incur a 20% late fee. Tuition that is not received by the 20th of each month will result in your child being unable to attend classes and you will still be responsible for paying tuition whether your child is in class or not. Tuition that is 2 months’ delinquent will be sent to collections. Unpaid tuition, costume fees or other charges that are sent to collections or retrieved in court will result in you paying tuitions as well as any legal or court fees incurred to The Dance Source.

4. RELEASE: By signing this contract you agree to release and forever discharge, The Dance Source and their employees from any liabilities growing out of or related to any activities in which I or my child may participate in. I understand that this is a full and complete release for all injuries or damages which I or my child may sustain as a result of my/his/her participation in any activities, regardless of the specific cause thereof.

5. PAYMENT: We accept Checks, Cash, Venom (@dancesource or Heidi Wright) or Credit / Debit card. A 3% convenience fee will be added to all credit / debit card transactions. Checks are protected by CheckRit; if your payment is returned you will be responsible to pay the check amount and the Return Fee. Any delinquent accounts after 2 months will be sent to collections.

6. PARENT RESPONSIBILITY: PLEASE pick up your child after their class or classes have been completed. Please do not leave your child here any longer than 15 minutes before or after their class schedule has started or finished. Parents may be charged a \$15 fee for each 15 min for students who are left at the studio unattended. THANK YOU

7. CLASS OBSERVATION: We have an open door policy and you are welcome to observe your child’s class through the viewing windows. However, if it distracts from the learning of your child you will be asked to leave, so your dancer can receive the best training.

8. CLASS ATTENDANCE: 100% attendance is encouraged. No Credit or Refund will be given for classes that you are unable to attend.

9. RECITAL/COSTUME FEE: The Dance Source holds their recital each year for all students in May. Each student will need to pay a recital fee for the May 2022 recital. There are NO refunds for the students that decide not to be in the recital after the fee is paid. Each class is to purchase a recital costume. If the student has not paid in full for their costume, one will not be ordered for the student. Each student must have the class costume to perform in the recital. To receive your costume ALL TUITION MUST BE PAID.
